ORDINANCE NO. 173

AN ORDINANCE OF THE CITY OF LOWRY CROSSING, TEXAS, ACCEPTING NORTH MEADOW DRIVE, MEADOW DRIVE, AND OVERLAND DRIVE AS PUBLIC STREETS WITHIN THE CITY OF LOWRY CROSSING; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, North Meadow Drive, Meadow Drive and Overland Drive were dedicated to the City of Lowry Crossing as public rights-of-way by plat filed July 17, 1987, and recorded in Volume G, Page 212 of the Map/Plat Records of Collin County, Texas; and

WHEREAS, at the time of said dedication the City of Lowry Crossing did not accept said rights-of-way as public streets, as the City had no means of maintaining such rights-of-way; and

WHEREAS, on September 21, 2001, the City of Lowry Crossing began adopting a tax rate for the city; and

WHEREAS, the City's tax-rate provides a means to maintain said rights-of-way; and

WHEREAS, the City Council finds that it is in the public interest to accept said rights-of-way as public streets within the City of Lowry Crossing; Now, Therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOWRY CROSSING, TEXAS:


Section 1. That North Meadow Drive, Meadow Drive and Overland Drive, as platted and dedicated by plat filed July 17, 1987, and recorded in Volume G, Page 212 of the Map/Plat Records of Collin, County, Texas, and as subsequently developed, are hereby accepted as public streets within the City of Lowry Crossing, Texas.

Section 2. That a copy of the plat dedicating said rights-of-way shall be attached to this ordinance to show the location and dimensions of the accepted rights-of-way.


Section 3. That this Ordinance shall take effect immediately upon its passage.




