



WHEREAS, the City Council of the City of Lowry Crossing, Texas has determined that it would be in the public interest to amend the use regulations contained in Section 15, "'C' Commercial District Regulations," of Ordinance No. 110, the Lowry Crossing Zoning Ordinance to allow new and used automobile sales in the Commercial District; Now, Therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOWRY CROSSING, TEXAS:**


**Section 1.** That Paragraph (2), "Permitted Uses," of Subsection 15-2, "Use Regulations," of Section 15, "'C' Commercial District Regulations," of Ordinance No. 110, as amended, is amended by changing the use "Automobile, New Sales" to "Automobile Sales."

**Section 2.** That Ordinance No. 110, as amended, shall remain in full force and effect, save and except as amended by this ordinance.

**Section 3.** That this ordinance shall take effect upon passage and publication.




